## FISCHER MAKES HIS POINT

In the controversy over whether or not world chess champion Robert Fischer will defend his FIDE title in 1975, almost no one has presented Fischer's complete point of view. Reading the full text of his telegram to the delegates of this year's FIDE congress in Nice. France may help to shed more reasonable light on Fischer's proposals for match conditions. ditions.

Greetings to all delegates on occasion of Fiftieth FIDE Congress

I would like to address myself to some of the important matters that you will vote upon, and give you what I regard as the professional grandmaster's viewpoint. I hope you will give careful consideration to my opinions before you vote.

views. I would emphasize following points: i oppose reducing cycle next World Championship from three years to two. For decades when title resided in Soviet Union, champion had to defend only once every three years. Now when Soviets have lost title there is proposal to increase mandatory frequency of matches, thus giving them more opportunity to regain title. I regard this as manipulation of rules to favor one country.

However, I have not received a challenge from any player in the world, and my attempts to interest various backers regarding a return match with Spassky have failed because of adverse effects of negative statements in press by Soviet Chess Federation and former World Champion Spassky as to advisability, practicality, and availability of Mr. Spassky to face me before 1975.

ions, whose function should be to assist and not to dic-to players. The two players are far more capable of hing agreement without political intervention. Player reaching agreement without political intervention. Player should inform FIDE in writing whenever he delegates rights to his federation.

I approve of clause for flexibility in changing rules by mutual agreement. Mutual agreement.

Now I speak of a very important matter. Official World Championship occurs only once in three years. Temporary form, or team preparation, or luck should not be permitted to determine result. World Champion should be world's best player, and long match is necessary to reach a just result with nearly absolute certainty. For this reason i propose that match be won by first player to win ten games, with no limit on total number played.

Provision for drawn match with score nine wins to nine with champion retaining title and prize fund split equally is consistent with long-standing tradition of small advantage for champion. Yet those who have long enjoyed this advantage now wish to abolish it. Propaganda emanating from a certain country has falsely implied that I am seeking unprecedented advantage. These critics say that it is unfair to require a two-point margin of ten wins to eight in order for challenger to win the match, yet only in this way can champion's advantage be fairly preserved when there is no limit on total games. And critics deliberately overlook that champion also needs two-point margin of ten wins to eight in limit on total number played. needs two-point margin of ten wins to eight in pion also order to win match.

Mr. Cramer can demonstrate the historical record, but, for example. Alekhine needed at least a margin of six to four to become World Champion, whereas Capablanca needed only five wins to retain his title, draws not counting.

Throughout my career I have always insisted on optimal conditions for my participation in chess competitions. I will not compromise on this principle for the 1975 World Championship match.

### KARPOV NOW TWO UP ON KORCHNOI

Posting his second very impressive win over Viktor Korchnoi in six tries. 23-year-old Anatoly Karpov now seems certain of ultimate victory in their final world championship candidates' match.

The first player to score five points, draws not counting, will become Robert Fischer's official challenger for the world title in 1975, or will be declared FIDE World Champion should Fischer elect not to play.

Here is the sixth match game (annotated version to follow), recorded in streamlined coordinate chess notation (files lettered "a" to "h", ranks numbered "1" to "8", always counting from White's lower left corner regardless of whose turn to move; pawn captures designated by file letters only).
